SUBJECT: CICA REQUIREMENTS (RACAD)

Dear Sir(s):

Please be aware that due to several observations made by Panama Maritime Authority regarding the issuance of CICA and the information contained in the RACAD, MCO Head Office has decided to guide you in order to avoid delays during the process of the above mention certificate.

We remind you that the following points shall be completed and filled up accordingly below instructions:

CREW SLEEPING ROOMS (I.L.O. Convention No. 92)

This part must be completed as per the information contained below to this table.

NOTES:

- 1. Enter: O for officers; P petty officers; M for miscellaneous; D for deck ratings; E for engine ratings; C for catering staff.
- 2. Indicate units. In odd-shaped cabins, indicate mean or approximate values.
- 3. Indicate units. Area includes berths, lockers and furniture, but excluded zones of difficult access.
- **4.** Enter: **P** for private; **S** for semi-private(4 person) **N** for none.

The number of persons allowed to occupy sleeping rooms shall not exceed the following maxima:

- (a). officers in charge of a department, navigating and engineer officers in charge of a watch and senior radio officers or operators: one person per room;
- (b). other officers: one person per room wherever possible, and in no case more than two;
- (c). petty officers: one or two persons per room, and in no case more than two;
- (d). other ratings: two or three persons per room wherever possible, and in no case more than four.

*If the vessel has more than 4 persons in a cabin (5 or 6) shall apply for an exemption of Article 10 of ILO 92.
